

Statement regarding REACH, POPs and RoHS

Arvid Nilsson fulfills the legal requirements in REACH, POPs and RoHS with respect to supplied articles on the European market. This conclusion is based on the valid versions of the legislations at the date of this statement and assurances from our suppliers. Apart from signed assurances from our suppliers we assure compliance by signing business agreements, which includes environmental aspects and follow up by supplier visits. More information on each legislation and how compliance is achieved is found in the Annex 1 to this declaration.

Please note that a few articles that we supply contains more than 0.1 percent lead and these articles are therefore not allowed to be used in the assembly of electric and electronic equipment according to the RoHS directive.

Arvid Nilsson hereby declares that all of our products appearing in catalogue and in stock are in compliance with the REACH regulation (EC No 1907/2006), POPs regulation (EC No 2019/1021) and RoHS directive (2011/65/EU) and (2015/863/EU). We also commit ourselves to continuously improving the environmental and health impact of our products by reducing hazardous substances that are not yet subjected to any legal requirements.

Annex 1. Information on legislation and how compliance is achieved

REACH Regulation (EC No 1907/2006)

Chemical substances in articles are regulated by the Candidate list and Annex XVII. The candidate list contains substances of very high concern (SVHC) that are subjected to information and registration requirements if the content exceeds 0.1 percent by weight. Apart from lead, no substances on the candidate list exceed the specified concentration limit in articles supplied by Arvid Nilsson. The information requirement for lead is fulfilled by providing information in our Web-shop and these articles are in addition registered in the SCIP database provided by the European Chemicals Agency (ECHA).

Annex XVII contains restriction for both chemical products and articles. Arvid Nilsson has identified the restrictions for professional use and the assessment based on assurances from our suppliers shows that Arvid Nilsson is compliant.

PFAS (Per- and Polyfluoroalkyl Substances)

We would like to inform you that Arvid Nilsson does not trade any products that contain PFAS (Per- and Polyfluoroalkyl Substances). We are dedicated to offering safe and environmentally friendly products, ensuring that all our offerings meet the highest standards of safety and sustainability.

POPs Regulation (EC No 2019/1021)

The POPs regulation bans or restricts the use of persistent organic pollutants in both chemical products and articles. Substances listed in Appendix 1 are not allowed to be present in chemical products or articles, with the exemption of unintentional trace contaminants below specified values. Based on assurances from our suppliers no articles from Arvid Nilsson contains the listed substances above the specified limit values.

RoHS Directive (2011/65/EU) and (2015/863/EU)

The RoHS directive restrict the use of certain hazardous substances in electrical and electronic equipment. The regulated substances are lead, mercury, cadmium, hexavalent chromium, two groups of brominated compounds and three specified phthalates. The concentration limit is 0.1 percent by weight (cadmium 0.01 percent). Apart from lead no articles contain the specified substances above the limits. This conclusion is based on assurances from our suppliers. For articles containing more than 0.1 lead we have included this information in our web-shop.
